Women's Health Awareness Climate Change in Your Community Challenge for North Carolina Middle Schools

The National Institute of Environmental Health Sciences (NIEHS) is seeking middle school science teachers and students to participate in the Climate Change in Your Community Environmental Health Challenge. This challenge focuses on schools in disadvantaged and/or underserved regions of North Carolina most likely to be impacted by climate-related disasters (e.g., hurricanes, wildfires, floods, etc.). Winning schools may receive up to \$1,000 to implement their projects within their local community.

What is the challenge? The Climate Change in Your Community Environmental Health Challenge is a citizen science project competition created for middle school students to learn and practice public participation and collaboration through scientific research. This is a science-based classroom project where educators can also incorporate collaboration with other core subject areas. The challenge highlights topics related to climate, climate change, and environmental health in North Carolina and aims to explore health effects, vulnerable populations, and specific areas in the state that experience negative health impacts due to disaster events and environmental hazards.

Who is eligible to participate: North Carolina 6th and 7th grade middle school science teachers and students.

*Preference will be given to schools located in disadvantaged and/or underserved communities
