- 1. Wōnej kōllāik oñāan Jerbalin Etale/Ekkatak in?** Health Resources and Services Administration eo ej kōllāik oñāan jermalin etale ekkatak in.
- 2. Ta eo renaaj kajjitōk bwe in kōmmane eļāñne inaa bōk koṇaō ilo jermal in etale/ekkkatak in?** Naaj kajjitōk bwe kwōn uwaake kajjitōk ko ilo jōrpe in etale eo.
