- 4. Do you have any criminal convictions in your past including criminal driving offenses and are you willing to submit to a background check for this study?
- 5. Are you willing to work at least willing to work at least five (5) days per week for 12 consecutive weeks during a three-month data collection cycle?
- 6. Health Questions:
  - a. Do you have a substance abuse condition? (including alcoholism)
  - b. Do you have a history of neck or back conditions which limit your ability to drive?
  - c. Do you have a history of brain damage from stroke, tumor, head injury, recent concussion, or disease or infection of the brain?
  - d. Do you have a current heart condition?
  - e. Do you have current uncontrolled respiratory disorders or disorders requiring oxygen?
  - f. Have you had epileptic seizures or lapses of consciousness within the last 12 months?
