### Vessel Sanitation Program (VSP)

The Department of Health and Human Services, Title 42, and the U.S. Code of Federal Regulations Part 71.8 Control of Communicable Diseases requires cruise ships to report all gastrointestinal illness cases to the Vessel Sanitation Program during the following designated times: before arriving to a U.S. port from a foreign port. This report is required even when there are no cases. It is made 24 to 36 hours before arriving to the United States; if the case counts of ill passengers or crew changes after making the initial notification; when 2% or more of the passengers or crew are ill with gastrointestinal illness (special report). This special report must be sent at any time the vessel is in the United States or within 15 days of arriving to a U.S. port; and when unusual symptoms are reported to the ship's medical staff.
