## E. REGISTRATION OF A PRODUCTION FACILITY FOR EXPORT OF NATIVE CITES SPECIES

This application is to be used by qualified production facilities to establish an annual registration, or master file, to export certain native species (if requesting authorization for sturgeon or paddlefish, please use form 3-200-76 or 3-200-80. The master file will allow the registrant to obtain a number of single-use CITES export documents (at a cost of \$5 each) for approved species. Please contact the Division of Management Authority or see our webpage at for a list of qualified species and conditions that must be met to qualify for registration, or to answer any questions you may have.

The U.S. FWS may not be able to issue CITES documents for the commercial export of Appendix-I specimens, unless the specimens were obtained from animals produced at a CITES-registered Appendix-I commercial breeding operation.
