E. EXPORT OF AMERICAN GINSENG (MULTIPLE COMMERCIAL SHIPMENTS)

Note: This application should be used to request authorization to export multiple commercial shipments of artificially propagated and wild-harvested American ginseng (*Panax quinquefolius*). For a single shipment of American ginseng, submit form 3-200-32.

This application establishes a Master File, valid for up to three years for artificially propagated American ginseng and one year for wild-harvested American ginseng (both are renewable), for commercial exports. Once the Master File is approved, you must obtain single-use permits, valid for 6 months for each export (50 CFR 13).

PRIVACY ACT STATEMENT
