SUPPORTING STATEMENT FOR PAPERWORK REDUCTION ACT SUBMISSION

This request is for an extension of the application booklet for the Strengthening Institutions Program (SIP), CFDA# 84.031A and 84.031F. SIP provides grants to eligible institutions of higher education (IHEs) to improve their academic programs, institutional management, and fiscal stability to increase their self-sufficiency and strengthen their capacity. Funding is targeted to institutions that enroll a large proportion of financially disadvantaged students and have low per-student expenditures. Section 311(b)¹ (hyperlinks provided for all laws and regulations) and Section 391(a)(1) of Title III, Part A of the Higher Education Act of 1965, as amended² (HEA), 20 US Code §1057 and the governing regulations (34 CFR 607.1-607.31) require collection of the information identified in the application package, in order to make awards.

Institutions submit an application detailing their comprehensive development plan (CDP) including the institution's strengths and weaknesses, the proposed activities to target weaknesses, the expected results and the evaluation plan. The collection of information will be 100% electronic, thereby minimizing burden to the fullest extent possible.

The information required to obtain funds from SIP is not collected elsewhere. The program allows institutions to choose from a myriad of legislatively allowable activities, which ones would best serve their current needs. That information is specific to the time the institution of higher education is applying for the grant.

Legislatively, all eligible IHEs that seek assistance under this program must submit the required data. If this information is not collected, the program cannot meet its statutory requirements and cannot make awards.
