All 29 FY 2019 TPP grantees and any FY 2020 TPP grantees that interact with the evaluation technical assistance contract via group TA (between 4 and 66 grantees) could receive surveys. Two individuals, the project director and lead evaluator, for each grantee would receive each survey referenced below.

Periodic TA surveys. There is a survey that would be administered after each group technical assistance activity, such as a webinar or conference presentation. Each survey would be administered to two respondents for each grantee (the project director and lead evaluator) after each activity. We estimate six activities throughout 2020 and 2021 for the 29 TPP19 grantees for a total of (6*29*2 =) 348 responses from the TPP19 grantees. And we expect one activity in 2020, and four activities per year in 2021 and 2022 for the TPP20 grantees. We assume that up to 40 grantees will receive each outreach, so we expect (9*40*2=) 720 responses for TPP20 grantees. Therefore, we will have up to 1,068 respondents for the group technical assistance surveys.
