# Supporting Statement for Paperwork Reduction Act Submissions Annual Reporting for Manufacturers of Listed Chemicals OMB Approval #1117-0029

The Drug Enforcement Administration (DEA) seeks approval by the Office of Management and Budget (OMB) for an existing collection of information that was previously approved by OMB – OMB Approval #1117-0029, Annual Reporting for Manufacturers of Listed Chemicals.

#### Part A. Justification

# 1. Necessity of Information:

Pursuant to 21 U.S.C. 830(b)(2) and 21 CFR 1310.05(d), manufacturers of listed chemicals must file annual reports of manufacturing, inventory, and use data for the listed chemicals they manufacture. These reports allow DEA to monitor the volume and availability of domestically manufactured listed chemicals, which may be subject to diversion for the illicit production of controlled substances.

#### 2. Needs and Uses:

DEA uses this information from businesses and other for-profit entities which manufacture listed chemicals domestically. The collection of this information enables DEA to monitor the domestic manufacture and availability of listed chemicals. This reporting is mandated by the Domestic Chemical Diversion Control Act of 1993. Failure to collect such information would impede DEA's enforcement of the Controlled Substances Act.

### 3. <u>Use of Information Technology:</u>

Respondents may submit reports electronically on DEA's Diversion Control Division web site (http://www.deadiversion.usdoj.gov), or in writing on company letterhead. Currently, 100% of DEA annual reports are submitted electronically.

### 4. Efforts to Identify Duplication:

DEA has made efforts to identify and prevent duplication of the collection of information. The collection information related to domestic listed chemical production is unique to DEA.

### 5. <u>Impact on Small Businesses or Entities:</u>

This information collection will not have a significant economic impact on small businesses or other small entities within the meaning and intent of the Regulatory Flexibility Act (5 U.S.C. 601–612).

# 6. Consequences of Less Frequent Collection:

The Controlled Substances Act requires this collection be conducted annually. 21 U.S.C. 830(b) (2). This annual reporting requirement allows DEA to carry out its policies and programs as they relate to the diversion of listed chemicals for the illicit manufacture of controlled substances. Respondents maintain the requested data as part of usual and customary business practice.

# 7. Special Circumstances Influencing Collection:

There are no special circumstances applicable to this information collection.

# 8. Consultation with persons outside the Agency:

Public comment was solicited in the 60-day Federal Register Notice of Information Collection, 87 FR 27186, published on May 6, 2022, and the 30-day Federal Register Notice of Information Collection, 87 FR 39128, published on June 30, 2022. DEA has yet to receive any comments concerning this collection.

DEA meets regularly with the affected industry to discuss policies, programs, and regulations. These meetings provide an open forum to discuss matters of mutual concern with representatives of those entities from whom the information is obtained.

### 9. Payment or Gift to Claimants:

This collection of information does not propose to provide any payment or gift to respondents.

### 10. Assurance of Confidentiality:

Information requested in this collection may be considered confidential business information if marked as such in accordance with 28 CFR 16.8(c) and Exemption 4 of the Freedom of Information Act (FOIA). Submitters who are required to furnish commercial or financial information to the government are protected from the competitive disadvantages that could result from disclosure of such information. The information is protected by DEA through secure storage, limited access, and federal regulatory and DEA procedures. In the event a FOIA request is made to obtain information that has been designated as confidential business information per 28 CFR 16.8(c) and Exemption 4 of FOIA, DEA will give written notice to the submitter to allow an opportunity to object within a reasonable time prior to any disclosure by DEA.

#### 11. Justification for Sensitive Questions:

This collection of information does not ask any questions of a sensitive nature.

#### 12. Estimate of Hour Burden:

Respondents submit reports on an annual basis, using information maintained as part of usual and customary business practice.

### 15. Reasons for Change in Burden:

There have been no changes to the annual burden hours reflecting no change in the chemical registrant population and manufacturing activity. The change in annual cost is due to updated hourly wage used in the calculation. For 2022, DEA used a national average, which is a bit lower, instead of a labor rate specific to 325400 - Pharmaceutical and Medicine Manufacturing industry. There have been no statutory or regulatory changes affecting this information collection. The table below summarizes the changes since the last renewal of this information collection.
