Federal Family Education Loan (FFEL) Program Secured Overnight Financing Rate (SOFR)

Election Form

The Department of Education (ED) is requesting approval of a new information collection for the FFEL Program SOFR Election form. On March 15, 2022, the President signed the Adjustable Interest Rate (LIBOR) Act into law. Among other things, the law amended section 438(b)(2)(I) of the Higher Education Act of 1965, as amended (HEA). This provision of the law requires FFEL Program lenders or an entity that holds a beneficial ownership interest in a FFEL Program loan (beneficial holder) to transition away from LIBOR based Special Allowance Payments (SAP) to a new formula set by the law based on SOFR. The transition may occur any time on or before June 30, 2023. However, a FFEL Program lender or beneficial holder must transition to the SOFR based SAP calculation by July 1, 2023, as a condition of continued participation in FFEL Program and to ensure accurate reporting as outlined in the HEA. The legal authority for collecting this information is Section 438(b)(2)(I) of the HEA, as amended by Public Law 117-103.

Lenders are required to file a quarterly report known as the Lender's Interest and Special Allowance Request and Report (OMB NO. 1845-0013) in order to claim subsidized interest payments and special allowance payments on qualifying FFEL loans. The SOFR election authorizes lenders under the LIBOR rate calculation to convert to SOFR rate calculation.

3. The information collected here is not available elsewhere due to the uniqueness of the collection.

Collection of this information does not impact small business.

This is a one-time collection. If the information is not collected ED will not be able to calculate the special allowance payments as mandated by law prior to the deadline date of July 1, 2023. This would restrict access to the lenders and beneficial holders of a statutory benefit.

There are no special circumstances. The collection of this information will be conducted in accordance with the guidelines in 5 CFR 1320.6.

On June 13, 2022 a notice was published in the Federal Register inviting public comment on the burden assessment in this collection and forms (Vol. 87, No. 114, pages 35975-35976). Two comments were received and responses from FSA are on the attached document. There are no changes to the documents based on these comments.

ED will now be requesting a 30-day public comment period to solicit comments on the current burden assigned to this regulation.

There are no plans to provide any payment or gift to respondents.

Please ensure the annual total burden, respondents and response match those entered in IC Data Parts 1 and 2, and the response per respondent matches the Paperwork Burden Statement that must be included on all forms.

The total annual burden has been determined to be approximately 2,048 hours. The estimated amount of time needed to collect, complete, review the information for accuracy, collect the required signatures, and maintain the appropriate documentation from each of the 128 estimated respondents is 16 hours. The estimated total annual cost will be \$161,792. This was determined by multiplying the estimated 2,048 burden hours by an average hourly wage of \$79 per hour.

This is a new collection based on a statutory change due to the pending termination of LIBOR; there are no changes or adjustments. Each respondent will submit documentation one time for a total of 128 responses and 2,048 burden hours.
