Under RFS2, RIN generating producers and importers of renewable fuel using *Arundo donax* or *Pennisetum purpureum* as feedstocks per §80.1426 may have additional reporting requirements under 80.1451(h).

### Reporting deadline

Submit this report by March 31<sup>st</sup> following the reported compliance year.
