

# Instructions for RFS0105: RFS Activity Report

#### Who must report

• Any party who owns RINs during a reporting period (any calendar quarter), must submit the required RFS Activity report.

## **Reporting requirements**

- Complete this report representing all required elements calculated as a single entry for the compliance period.
- 40 CFR 80.1451(a) and (c) sets forth the additional reporting requirements (available at: <u>http://www.ecfr.gov/cgi-bin/text-idx?</u> <u>SID=92f329a74300c94eb629af9882f2297a&mc=true&node=se40.19.80</u> 11451&rgn=div8)
- **Required fields and NA values** Certain report fields or parameters may be specific to select product types. If a report field does not apply to the reported batch, enter the value "NA". Do not leave the field blank.

### **Reporting deadlines**

• All RIN owning parties shall report on a quarterly basis:

Calendar Quarter	Time Period Covered	Quarterly Report Deadline
Quarter 1	January 1 – March 31	June 1
Quarter 2	April 1 – June 30	September 1
Quarter 3	July 1 – September 30	December 1
Quarter 4	October 1 – December 31	March 31
