

RFS2 Activity Report (RFS0104): Instructions for Completing

Who must report

• All parties who own RINs during a reporting period (any calendar quarter), must submit the required RFS2 Activity report.

Reporting requirements

- Complete this report representing all required elements calculated as a single entry for the compliance period.
- 40 CFR 80.1451(c) sets forth the additional reporting requirements (available at: http://www.ecfr.gov/cgi-bin/text-idx?

- **Required fields and NA values** Certain report fields or parameters may be specific to select product types. If a report field does not apply to the reported batch, enter the value "NA". Do not leave the field blank.

Reporting deadlines

• All RIN owning parties shall report on a quarterly basis:

Quarter 1	January 1 – March 31	June 1
Quarter 2	April 1 – June 30	September 1
Quarter 3	July 1 – September 30	December 1
Quarter 4	October 1 – December 31	March 31
