

## RFS2 Renewable Fuel Producers Reporting Fuels for 80.1451(b)(1)(ii)(T) (RFS1400): Instructions for Completing

### Who must report

- RFS2 Producers of renewable fuel required to submit additional information under 80.1451(b)(ii)(T). Specifically, any producer generating RINs for renewable fuel that is **NOT** one of the following types:
  - o Ethanol
  - o Biodiesel
  - o Renewable Gasoline
  - o Renewable diesel that meets ASTM D 975-13a Grade No. 1-D or No. 2-D specifications
  - o Renewable CNG or LNG
  - o Renewable Electricity

### Reporting requirements

- Enter a separate report line for each distinct fuel type.
- **Required fields and NA values** – Certain report fields or parameters may be specific to select product types. If a report field does not apply to the reported batch, enter the value “NA”. Do not leave the field blank.

### Reporting deadlines

- Producers shall report on a quarterly basis:

| Production Calendar Quarter | Time Period Covered     | Quarterly Report Deadline |
|-----------------------------|-------------------------|---------------------------|
| Quarter 1                   | January 1 – March 31    | June 1                    |
| Quarter 2                   | April 1 – June 30       | September 1               |
| Quarter 3                   | July 1 – September 30   | December 1                |
| Quarter 4                   | October 1 – December 31 | March 31                  |
