A. Justification

- 1. Explain the circumstances that make the collection of information necessary. Identify legal or administrative requirements that necessitate the collection of information.**

This form is used by the Department of Veterans Affairs to allow authorized agents (Guardian, POA, VA Fiduciary) to update information on a Veteran's VALife policy. The form is authorized by 38 USC, Section 1922.

- 2. Indicate how, by whom, and for what purposes the information is to be used; indicate actual use the agency has made of the information received from current collection.**

The data collected on this form is used by the Department of Veterans Affairs to update contact information, communication preferences, beneficiary information payment method and to make changes to or cancel coverage or apply to reinstate a lapsed policy for VALife policies, which opens to enrollment on January 1, 2023.

VA Form 29-10279 will be available as a DocuSign form through the Insurance website. While most VALife applicants will manage their policy changes through their online account, this form is for authorized agents (Guardian, POA or VA Fiduciary) to update information on behalf of Veterans who are unable to manage their VALife coverage on their own. Agents who need to update information on behalf of a VALife insured will be directed to the DocuSign version of the form to complete and submit through a secure DocuSign portal.

4. Describe efforts to identify duplication. Show specifically why all similar information already available cannot be used or modified for use for the purposes described in Item 2 above.

The information is not contained in any other VA records. Similar information is not available elsewhere.

5. If the collection of information impacts small businesses or other small entities, describe any methods used to minimize burden.

The information does not involve any small businesses.

This form is designed for use by the Department of Veterans Affairs to maintain Veterans Affairs Life Insurance (VALife) accounts.

The Department notice was published in the Federal Register on June 29, 2022, Volume 87, No. 124, Pages 38834 and 38835. The information does not involve obtaining information from any state or local Government. There is no person or organization other than VA that will collect the information which is submitted by the insured. No comments were received in response to this notice.

9. Explain any decision to provide any payment or gift to respondents.

The information collected is supplied by the respondent. No remuneration is made.

10. Describe any assurance of confidentiality provided to respondents and the basis for the assurance in statute, regulation, or agency policy.

The information collection conforms with the Privacy Act of 1974 and is subject to the conditions of disclosure contained therein. The records are maintained in the system identified as 36VA29, “Veterans of Uniformed Services Personnel Programs of U.S. Government” as contained in the Privacy Act Issuances, 1993 Compilation.

11. Provide additional justification for any questions of a sensitive nature, such as sexual behavior and attitudes, religious beliefs, and other matters that are commonly considered private; include specific uses to be made of the information, the explanation to be given to persons from whom the information is requested, and any steps to be taken to obtain their consent.

There are no questions of a sensitive nature.

12. Estimate of the hour burden of the collection of information:

- a. Number of Respondents: 2500
- b. Frequency of Response: On occasion
- c. Annual Burden Hours: 417 hours
- d. Estimated Completion Time: 10 minutes
- e. The Bureau of Labor Statistics (B:S) gathers information on full-time wage and salary workers. According to the latest available BLS data, the mean weekly earnings of full-time wage and salary workers are \$1,120.40. Assuming a forty (40) hour work week, the mean hourly wage is \$28.01 based on the BLS wage code – “00-0000 All Occupations.” This information was taken from the following website:

Legally, respondents may not pay a person or business for assistance in completing the information collection. Therefore, there are no expected overhead costs for completing the information collection. VBA estimates the total cost to all respondents to be **\$70,025** (2500 burden hours x \$28.01 per hour).

This submission does not involve any record keeping costs.

The processing time estimates above are based on the actual amount of time employees of each grade level spend to process to completion a claim received on this form. The within-grade step (3) of each employee represents the average experience of employees within each grade.
