According to our records, you are not qualified for benefits under the Railroad Unemployment Insurance Act based on your 2018 railroad earnings.

To be qualified for benefits in the general benefit year July 1, 2019 through June 30, 2020, you must have had railroad earnings of at least \$3900.00 in 2018, counting no more than \$1560 for any month.
