ATTACHMENT A DoD IASP Proposal Preparation Instructions

Proposals Returned without Review:

Proposals that do not conform to the requirements stated in this document may <u>not be</u> considered for the DoD IASP Academic Solicitation year 2013-2014. Requirements include such things as page limits, formatting instructions, use of required and current forms, and meeting deadlines.

Format of the Proposal:

The proposal must be clear, readily legible, and conform to the following requirements:

- a. Use one of the following typefaces identified below:
 - Arial, Courier New, or Palatino Linotype at a font size of 10 points of larger
 - Times New Roman at a font size of 11 points or larger
 - Computer Modern family of fonts at a font size of 11 points or larger
 - **NOTE**: A font size of less than 10 points may be used for mathematical formulas or equations, figure, table or diagram captions and when using a Symbol font to insert Greek letters or special characters. PIs are cautioned, however, that the text must still be readable;
- b. No more than 6 lines of text within a vertical space of 1 inch; and
- c. Margins, in all direction, must be at least an inch.

Proposal Requirements:
