Printing  
Forms

SSA offers our forms in Portable Document Format (PDF). PDF files are printer independent using any printer. To read and print a PDF publication, you must have the Adobe Acrobat Reader software installed on your PC. You can download the Adobe Acrobat Reader version suitable for your system by clicking on this button. There is no charge for this software.



SSA forms must be printed on 8 1/2" x 11" white paper. You must print the form with blue or black ink to be acceptable to SSA.

NOTE: if you live abroad, and cannot obtain 8.5 x 11 paper, the use of A4 size paper (8.25 x 11.7) is the only acceptable alternative.

## Third Party Organizations Who Want to Reproduce SSA Forms

### Overview

If a third party organization outside of the Social Security Administration (SSA) would like to reproduce an SSA form or publication, the organization must receive written approval from SSA prior to reproducing the item. Prior approval is required if the organization intends to charge a fee.

Section 1140(a)(2) of the Social Security Act provides as follows:

"No person may, for a fee, reproduce, reprint, or distribute any item consisting of a form, application, or other publication of the Social Security Administration unless such person has obtained specific, written authorization for such activity in accordance with regulations which the Commissioner of Social Security shall prescribe."

Furthermore, SSA's regulation at 20 CFR 422.527 also requires prior approval:

"Any person, institution, or organization wishing to reproduce, reprint, or distribute any application, form, or publication prescribed by the Administration must obtain prior approval if he or she intends to charge a fee. Requests for approval must be in writing and include the reason or need for the reproduction, reprinting, or distribution; the intended users of the application, form, or publication; the fee to be charged; any proposed modification; the proposed format; the type of machinery (e.g., printer, burster, mail handling), if any, for which the application, form, or publication is being designed; estimated printing quantity; estimated printing cost per thousand; estimated annual usage; and any other pertinent information required by the Administration. Forward all requests for prior approval to: Office of Publications Management, 6401 Security Boulevard, Baltimore, MD 21235-6401."

### How to Request Approval

To receive approval, the third party organization must first submit the following information to SSA on company letterhead:

1. The title and form number to be reproduced,
2. A summary of how the reproduced form will be used,
3. The services that the customer is receiving, if a fee is being charged,
4. The requesting organization's name and corporate address,
5. The requesting individual's name and address,
6. The requesting individual's area code and telephone number,
7. A reproduction of the form to be reviewed,
8. A description of how the organization intends to provide only the most up-to-date edition of SSA forms.

Upon consideration and review, the organization may be approved to reproduce SSA forms on a case by case basis. At such time, the organization will be issued a unique, identifying company code. The company code will be required to print out on each page of the form in the lower left corner. If the approval process is not completed, the organization's reproductions may not be accepted by SSA.

Once approved, the third party organization is responsible for resubmitting reproductions when SSA forms are updated. Only current SSA forms may be reproduced.
