**DIRECTIONS FOR MAILING QUARANTINE MATERIALS UNDER PERMIT TO THE UNITED STATES.**

Only materials covered by the permit will be shipped under green/yellow label (PPQ 508). Other materials will be denied entry. Place within the package the permittee's name, address, phone number, invoice, and, when required, a phytosanitary certificate. PPQ will not pay shipping charges. It is the permittee's responsibility to insure shipment is paid in full to its final destination. Attach the green/yellow permit label to the outside of the shipping container, making sure it is clearly visible and unobstructed by other shipping labels. If another shipping label must be attached, the address on the shipping label must match the address on the green/yellow label. This will ensure proper delivery. Do not duplicate the label. Only original labels will be accepted. Do not write on the label. Do not place any other delivery address on the outside of the package. On the outside of the package, place the name and address of the shipper and a statement of contents.
