## Internship Program

The Navy JAG Corps offers summer internships and school year externships to law students wishing to gain valuable legal experience, the opportunity for academic credit, and greater insight into life as a Navy judge advocate. As a Navy JAG Corps intern/extern, you'll be assigned to a legal command/staff and gain experience in traditional Navy JAG Corps practice areas such as military justice (criminal prosecution and defense), legal assistance (providing general legal advice to Sailors and their families), and command services (advising military commanders and their staffs).



### WHO IS ELIGIBLE

To be eligible for an internship or externship position with the Navy JAG Corps, you must:

### Summer Internships

- 2019 Summer Paid Internship Program: TBD based on available funding (exact date TBD).

### Fall Externships

The Fall 2018 externship application is due Friday, June 8, 2018. Selections will be made in June 2018.

### Spring Externships

The Spring 2019 externship application will be due in September 2018. Exact deadlines will be posted here and on our Facebook page when available.

## APPLICATION PROCESS

When submitting your internship or externship application, please keep your e-mail size smaller than 7MB; you may send multiple e-mails if necessary. After submitting your application, you will receive a confirmation e-mail within five business days. If you do not receive a confirmation e-mail please call (202) 685-8527 to confirm that your application has been received.*

Applications and required documents must be submitted via **e-mail** in PDF format. Applications, to include all required documents, must be received by midnight (Eastern Time) on the application deadline. **Structured interviews are not required for the summer internship or school year externship programs.** Letters should be addressed to the "Special Assistant for Recruiting".
