Purpose of Form

If, during the reporting year, a designated entity has assigned or transferred a designated entity license to another designated entity, the designated entity that holds the designated entity license on September 30 of the year in which the application for the transaction is filed is responsible for filing the annual report.

Annual Report

The annual report, which should be filed as an attachment to this Form 611-T, shall include:
