A customer reached out to us regarding some clerical errors that are present on the current Standard Form 180, in the address table at the bottom of page three. These are errors on my part that should have been corrected before they were sent to Reza for accessibility updates.

Some of the addresses include information on the improper lines, which may have led to undeliverable mail (as was the case with this requester due to box 13). I attempted to unlock this form to make these minor corrections, but was unable to do so. I'm guessing it was because this form was last updated by Reza with GSA and some additional security measures were put in place.

I have drafted an update to this address table, and all changes are minor. If at all possible, could we have them corrected on the official form? Once completed, I could pass a copy of the updated form along to our web team to have the new version posted to the Archives site at the link above. The updated table is pasted below for reference:
