Frequently Asked Questions

Why is this study being done?

Good nutrition is key to proper childhood development, but little is known about the food children are eating or their opportunities for physical activity while in child care. In recognition of the importance of nutrition and physical activity in child care, Congress directed USDA to conduct a nationally representative study of child care centers and family child care homes.

Who is conducting the study?

Mathematica and Westat are conducting SNACS-II for USDA. Their staff will be working with your child care provider to coordinate study activities.

Why did you choose my household?

Your household was randomly chosen using a scientific method from an enrollment list at the child care center your child attends. We want to talk with you so that our findings represent all households whose children attend child care centers that participate in CACFP.

Will I be compensated for my time?

Yes. Please see our study website for more information on compensation for your time.

Do I have to do this study?

Parent, child, and youth participation is voluntary. Being part of the study will not affect any USDA benefits received by programs or families participating in this data collection.

What study activities will my child participate in?

Depending on the age of your child (infant, child or youth), they may participate in a variety of study activities. Please visit our website for the details.

Can this impact my benefits or my child's status at the center?

Being part of the study will not affect CACFP benefits for programs or families.

Why is our participation important?

You and your household can help FNS to support improvements in the CACFP program.

What kind of questions will you ask in the parent phone interview?

We will ask about foods your child consumed outside of child care or brought into child care from home; your child's activity levels and screen time; and participation in food assistance programs.
