Craft Beverage Modernization Act (CBMA)

TTB administers CBMA tax benefits for imported alcohol entered for consumption in the United States on or after January 1, 2023. These tax benefits may be assigned by foreign producers to importers. What is Login.gov

Login.gov is a service that offers secure and private online access to government programs, such as federal benefits, services and applications. With a Login.gov account, you can sign into multiple government websites with the same email address and password.

Why is myTTB using Login.gov?

Login.gov uses two-factor authentication, and stronger passwords, that meet new National Institute of Standards of Technology requirements for secure validation and verification. By using Login.gov, you'll get an extra layer of security to help protect your account against password compromises.

Claims

You may file quarterly refund claims based on (1) the amount of tax you paid to U.S. Customs and Border Protection (CBP) on foreign distilled spirits, wine, and/or beer, and (2) any reduced tax rates or tax credits assigned to you by the foreign producer.

Requirements to submit a claim

- You must have received a foreign producer assignment for the year that you imported the products;
- When filing your consumption entry and entry summary with CBP, you must have included your TTB permit number as well as the foreign producer's TTB ID and CBMA assignment data in CBP's Automated Commercial Environment (ACE); and
- You must have paid the tax on the entry.

If required information is missing or incorrect in ACE, you will not be able to submit refund claims unless you correct the information filed with CBP. To view entry and entry summary data filed with CBP, log into the importer's ACE account (link) or contact your customs broker.

Claim Selection

Claim selection help

The claimed amount will be based on:

- the amount of tax you paid to U.S. Customs and Border Protection (CBP) on foreign distilled spirits, wine, and/or beer, and
- any reduced tax rates or tax credits assigned to you by the foreign producer for the year of importation.

Importers of distilled spirits paying tax to CBP at a lower effective tax rate based on eligible wine and/or flavor content should note that amounts claimed cannot exceed the amount of tax paid.

This module will allow you to submit claims for TTB review when the data you filed in CBP's Automated Commercial Environment (ACE) corresponds to a foreign producer assignment made through the TTB system. See [\[Link to forthcoming Guidance\]](#) to learn how data discrepancies can prevent you from submitting a refund claim electronically to TTB.

If required information is missing or incorrect in ACE, you will not be able to submit TTB refund claims through his system unless you correct the information filed with CBP.
