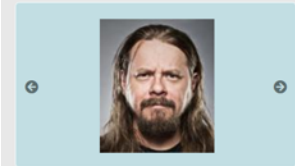

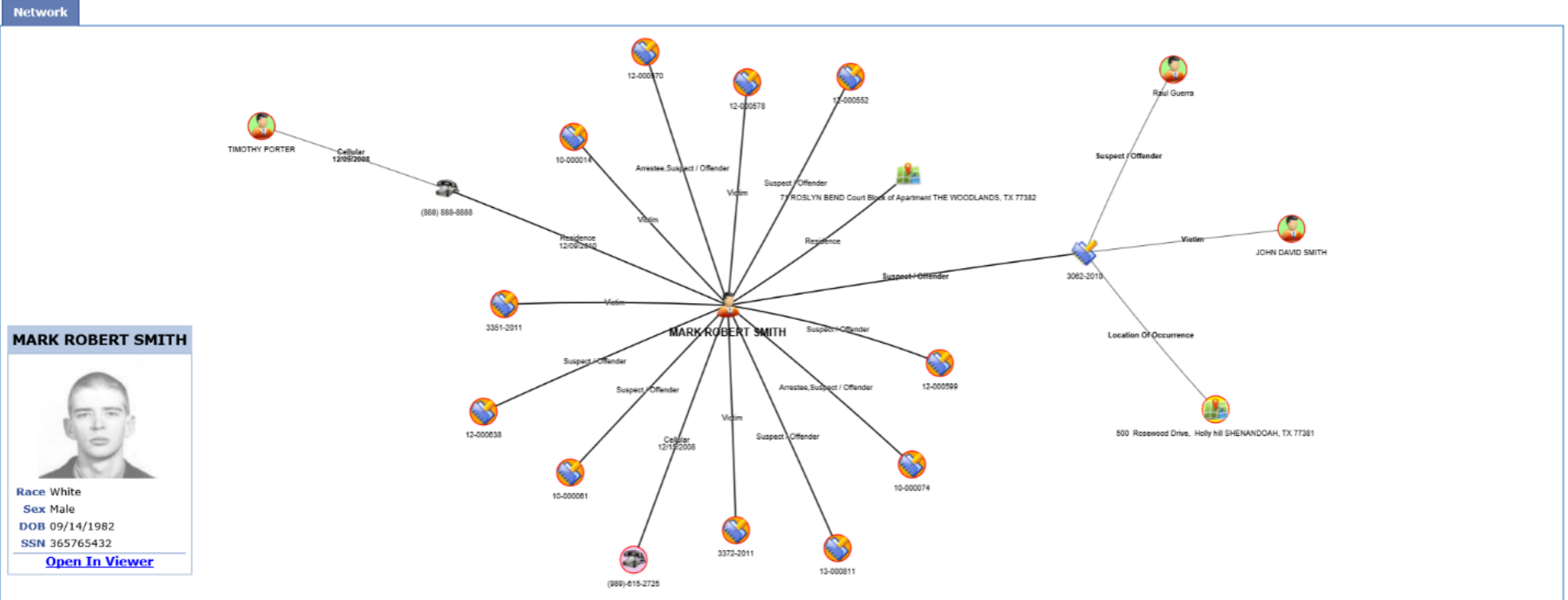


Figure 23: Online RMS – Visualization Tool (Note this page has not undergone the UI update. Effort in progress)

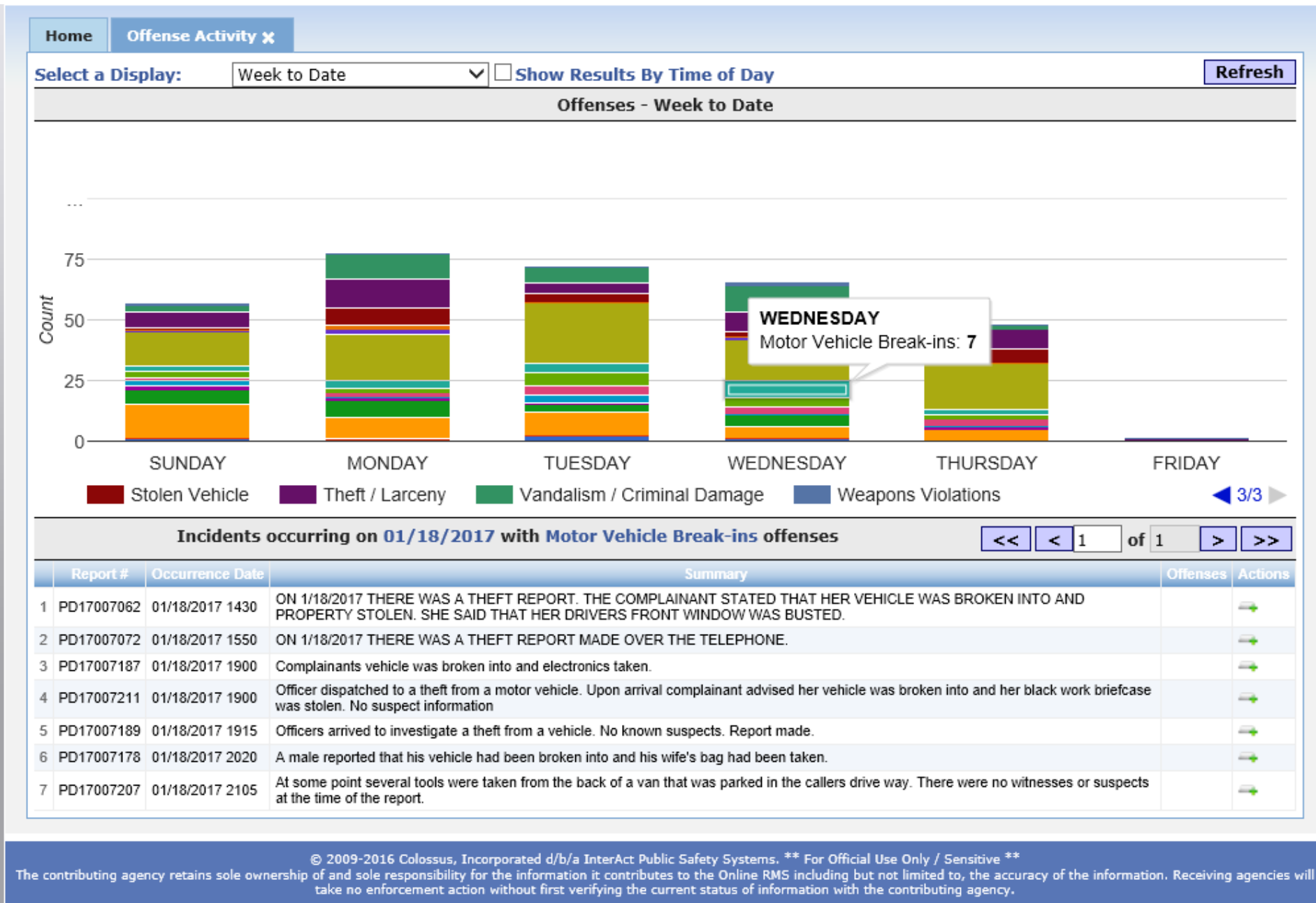


Figure 24: Online RMS - Offense Activity Charts Page (Note this page has not undergone the UI update. Effort in progress)

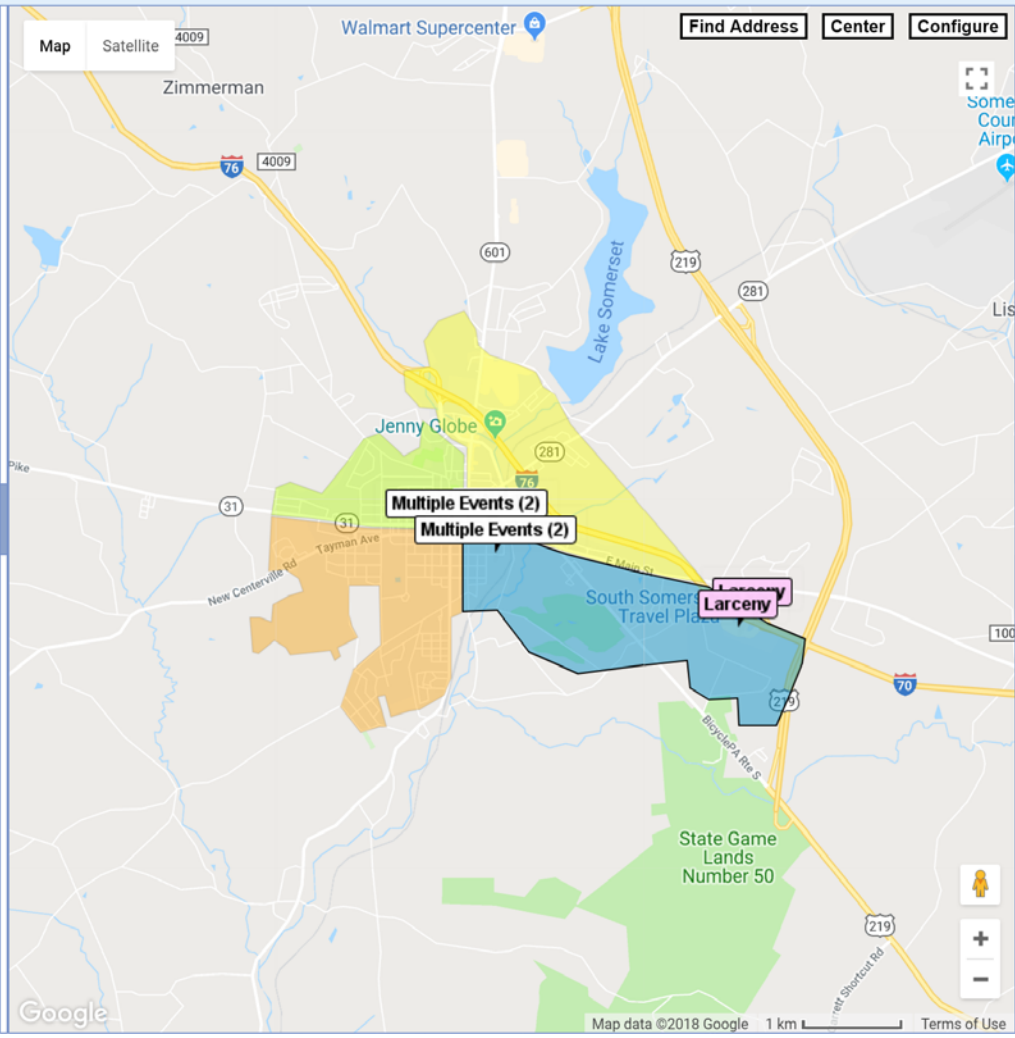
