# SUPPORTING STATEMENT VA FORM SGLV 8600 and SGLV 8600a SERVICEMEMBERS' GROUP LIFE INSURANCE – TRAUMATIC INJURY PROTECTION (TSGLI) APPLICATION FOR TSGLIL BENEFITS AND TSGLI APPEAL REQUESET FORM

# A. Justification

1. Explain the circumstances that make the collection of information necessary. Identify legal or administrative requirements that necessitate the collection of information.

The SGLV 8600 form is used by the Department of Veterans Affairs to request information in order to adjudicate TSGLI claims for benefits. The form is filled out by members or former members of the uniformed services who have suffered a traumatic injury while in service, and the uniformed services approve or disapprove the claim. If the uniformed services approve the TSGLI claim, then the insurer for the TSGLI program, The Prudential Insurance Company of America (Prudential), pays the claim. The form is authorized by 38 USC 1980A and 38 CFR 9.20.

The SGLV 8600a form is used by the Department of Veterans Affairs to request information in order to adjudicate TSGLI appeals for benefits. The form is filled out by members or former members of the uniformed services who have suffered a traumatic injury while in service and had their TSGLI claim disapproved. The form is authorized by 38 USC 1980A and 38 CFR 9.20.

2. Indicate how, by whom, and for what purposes the information is to be used; indicate actual use the agency has made of the information received from current collection.

The data collected is used by the uniformed services and Prudential in order to determine if a member or former member who has suffered a traumatic injury while in service is eligible to receive TSGLI benefits.

Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g. permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Also describe any consideration of using information technology to reduce burden.

The SGLV 8600 is available online on the VA Life Insurance website in a fillable electronic format. By allowing members and former members of the uniformed services to submit the form online reduces the burden on the member or former member because they are not required to print out the form and mail it to the uniformed services and Prudential.

The SGLV 8600a is available online on the VA Life Insurance website in a fillable electronic format. By allowing members and former members of the uniformed services to submit the form online reduces the burden on the member or former member because they are not required to print out the form and mail it to the uniformed services and Prudential.

4. Describe efforts to identify duplication. Show specifically why all similar information already available cannot be used or modified for use for the purposes described in Item 2 above.

The information is not contained in any other VA records. Similar information is not available elsewhere.

5. If the collection of information impacts small businesses or other small entities, describe any methods used to minimize burden.

The information does not involve any small businesses.

6. Describe the consequences to Federal program or policy activities if the collection is not conducted or is conducted less frequently as well as any technical or legal obstacles to reducing burden.

The data collected is used by the uniformed services and Prudential in order to determine if a member or former member who has suffered a traumatic injury while in service is eligible to receive TSGLI benefits. If the collection does not take place, then members and former members may not receive TSGLI benefits which they are eligible to receive.

The Department 60 Day Notice will be published in the Federal Register shortly after the approval of the emergency request as part of the process of obtaining non-emergency approval of this collection. The information does not involve obtaining information from any state or local Government. There is no person or organization other than VA that will collect the information which is submitted by the insured. No comments were received in response to this notice.

9. Explain any decision to provide any payment or gift to respondents.

The information collected is supplied by the respondent. No remuneration is made.

10. Describe any assurance of confidentiality provided to respondents and the basis for the assurance in statue, regulation, or agency policy.

The information collection conforms with the Privacy Act of 1974 and is subject to the conditions of disclosure contained therein. The records are maintained in the system identified as 36VA29, "Veterans of Uniformed Services Personnel Programs of U.S. Government" as contained in the Privacy Act Issuances, 1993 Compilation.

11. Provide additional justification for any questions of a sensitive nature, such as sexual behavior and attitudes, religious beliefs, and other matters that are commonly considered private; include specific uses to be made of the information, the explanation to be given to persons from whom the information is requested, and any steps to be taken to obtain their consent.

There are no questions of a sensitive nature.

## 12. Estimate of the hour burden of the collection of information:

- a. Total Number of Respondents: 758 (574 (SGLV 8600) and 184 (SGLV 8600a))
- b. Frequency of Response: One time
- c. Total Annual Burden Hours: 190
- d. Average Estimated Completion Time: 15 minutes

- e. The respondent population for SGLV 8600 and SGLV 8600a is composed of members and former members of the uniformed services who have suffered a traumatic injury while in service.
- f. The Bureau of Labor Statistics (B:S) gathers information on full-time wage and salary workers. According to the latest available BLS data, the mean weakly earnings of full-time wage and salary workers are \$1,120.40. Assuming a forty (40) hour work week, the mean hourly wage is \$28.01 based on the BLS wage code "00-0000 All Occupations." Legally, respondents may not pay a person or business for assistance in completing the information collection. Therefore, there are no expected overhead costs for completing the information collection. VBA estimates the total cost to all respondents to be \$21,232 (758 burden hours x \$28.01 per hour).

This submission does not involve any record keeping costs.
