

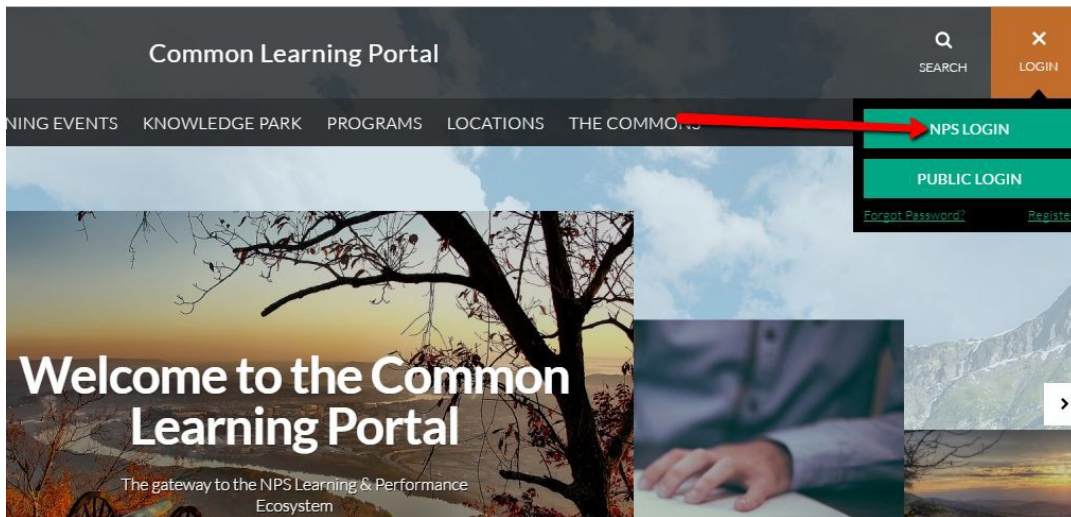

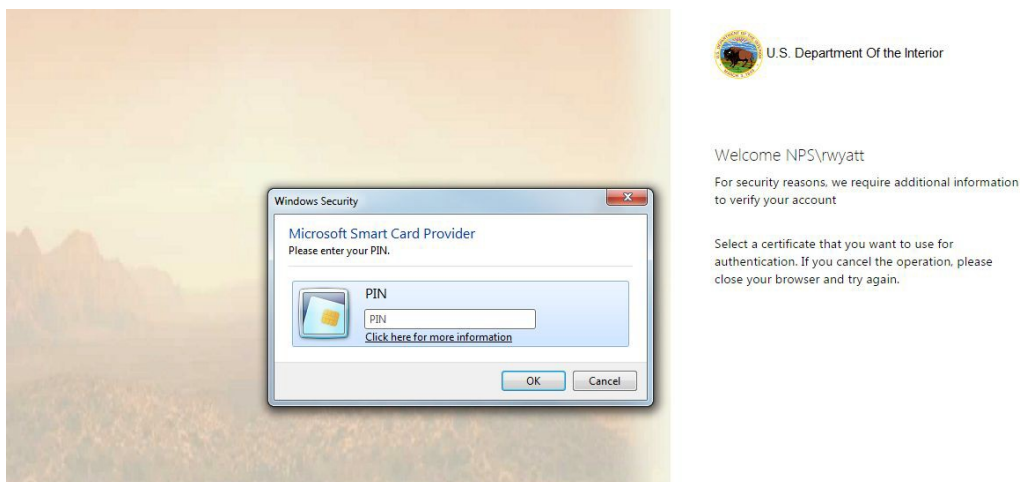
NPS Registration/Login Process (SAML Authentication)

Select NPS Login



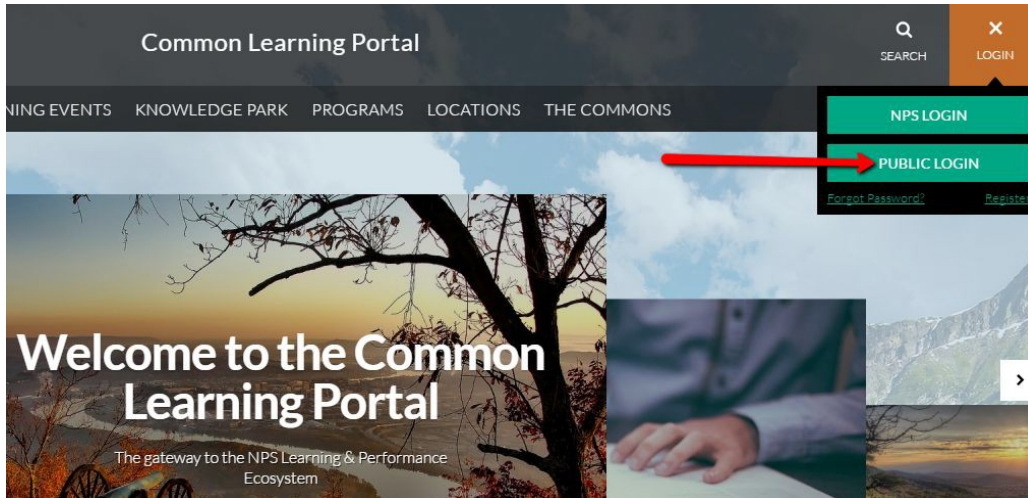
Select certificate and enter SAML Pin number
