	The filing fee for Form I-698 is \$1,670 , regardless of when it is filed. A biometric	

services fee of **\$85** is also required for applicants between 14 and 79 years of age.

NOTE: The filing fee and biometric services fee are not refundable, regardless of any action USCIS takes on this application. **DO NOT MAIL CASH**. You must submit all fees in the exact amounts.

Use the following guidelines when you prepare your checks or money orders for the Form I-698 filing fee and biometric services fee:

- **1.** The check or money order must be drawn on a bank or other financial institution located in the Unites States and must be payable in U.S. currency; **and**
- 2. Make the checks or money orders payable to **U.S. Department of Homeland Security**.

NOTE: Spell out U.S. Department of Homeland Security; do not use the initials "USDHS" or "DHS."

Notice to Those Making Payment by Check. If you send us a check, USCIS will convert it into an electronic funds transfer (EFT).
