

## RFS2 Renewable Electricity Generator – Renewable Electricity Data Transfer Report (Report Form ID: RFS4400): Instructions for Completing

### Who must report

- Generally, a Renewable Electricity Generator producing renewable electricity for use to produce a biogas-derived renewable fuel must comply with the reporting requirement found at 40 CFR § 80.150(c).

### Reporting Deadlines

- Renewable electricity generators must submit such information or reports on monthly renewable electricity batches by the end of the subsequent calendar month.
