

## RFS2 Biogas Producer Closed Distribution System – Volume Report (Report Form ID: RFS5000): Instructions for Completing

### Who must report

- Generally, a Biogas Closed Distribution System must comply with the reporting requirement found at 40 CFR § 80.150(g).

### Reporting Deadlines

- Biogas Closed Distribution System must submit on a quarterly basis.

Production Calendar Quarter	Time Period Covered	Quarterly Report Deadline
Quarter 1	January 1 – March 31	June 1
Quarter 2	April 1 – June 30	September 1
Quarter 3	July 1 – September 30	December 1
Quarter 4	October 1 – December 31	March 31
