

## RFS2 RNG RIN Separator – Total Volume Report (Report Form ID: RFS5200): Instructions for Completing

### Who must report

- Generally, a RNG RIN separator must comply with the reporting requirement found at 40 CFR § 80.150(g).

### Reporting Deadlines

- RNG RIN Separators must submit on a quarterly basis.

Quarter 2	April 1 – June 30	September 1
Quarter 3	July 1 – September 30	December 1
