



In preparation for the upcoming Bi-annual and Annual updates to tobacco registration and product listing:

- Section 905(b) of the FD&C Act requires establishment registrations to be re-submitted annually on or before December 31st of each year
- Section 905(i)(3) of the FD&C Act requires that certain changes in the product list be submitted bi-annually; once during June and once during December

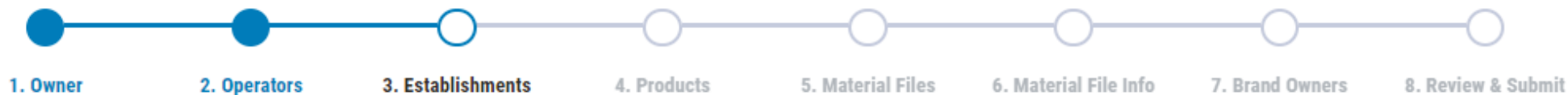

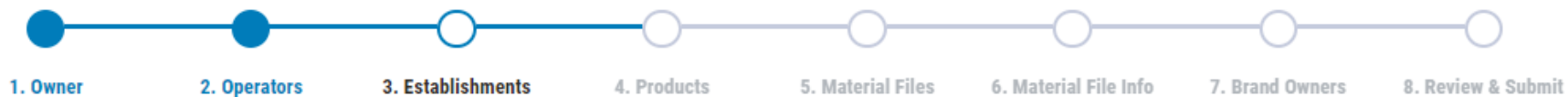

1. After opening the TRLM Product Listing Template, enable your macros when prompted.
2. Select the Data tab below and enter a new row per product. Tobacco products that differ (i.e., flavor, size, packaging, nicotine levels, etc.) must be listed individually on separate rows. Do not include products which have already been added or uploaded to your TRLM product listing, as they will be flagged as duplicates. Each template can list up to 1,000,000 products. If your product listing exceeds 1,000,000, you must complete and upload multiple templates.
3. At a minimum, provide information in column B (Product Name), column E (Intended Use of Product), column F (Product Category), and column G (Product Sub-Category). Do not rearrange, delete or add columns to the template as the system will not accept your revised template.
4. When you have completed entering your product information, select "Validate Data" button in the TRLM NG ribbon.
5. Export the template to CSV by selecting the "Export to CSV" button in the TRLM NG ribbon. The system will not accept any other file formats. Proceed to step 2b as listed in the Products page to upload the completed product listing spreadsheet. For Mac users, refer to the Industry User Manual available on the "Need Help?" page for further instructions on how to save the template as a CSV file. For optimal user experience, it is recommended that users perform bulk upload of products using a Windows machine.

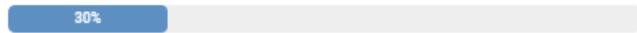
