# Registration Process and Description

The steps that follow outline the registration process for the HUD Housing Counselor Certification Exam and data transfer to the HUD FHA Connection system.

## Step 1

Counselor registers for an account on [HUDHousingCounselors.com](https://www.hudhousingcounselors.com).

- Enter email address to register as a new user. The Bixal system will generate a verification email with instructions.
- Verify email address and follow instructions to create a password. By default, the email address is the login ID.

#### Step 3
