## FDA FFR IDs

TTB will verify the FDA FFRs on this registration with other U.S. government agencies.

## Foreign Producer Ownership

Under U.S. law:

You may only assign U.S. tax benefits to an importer with a valid TTB permit number or reference number.

**Under U.S. law:**

**Each foreign distilled spirits operation can assign:**

- \$2.70 per proof gallon tax rate on the first 100,000 proof gallons imported, and
- \$13.34 per proof gallon tax rate on the next 22,130,000 proof gallons imported.

**Each foreign wine producer can assign:**

- \$1 tax credit per wine gallon on the first 30,000 wine gallons of wine imported (or 6.2 cent credit per wine gallon for wine classified as "hard cider"),
- 90 cent tax credit on the next 100,000 wine gallons imported (or 5.6 cent credit for hard cider), and
- 53.5 cent tax credit on the next 620,000 wine gallons imported (or 3.3 cent credit for hard cider).

**Each foreign brewer can assign:**

- \$16 per barrel tax rate on the first 6,000,000 beer barrels.

When foreign producers are related through common ownership to other foreign or U.S. producers, U.S. law may limit the tax benefits that each foreign producer can assign. It is the foreign producer's responsibility to ensure that it does not assign benefits in excess of the quantities allowed.
