CHIPS Credit

(48D) Advanced Manufacturing Investment Credit
Creates a 25% tax credit for investments in semiconductor manufacturing.

IRA Credits

(30C) Alternative Fuel Refueling Property Credit
Extends an existing tax credit eligibility period and modifies the credit for EV charging equipment.

(45) Renewable Electricity Production Credit
Amends 45(d) electricity production credit, including changes for an investment credit under 48.

(45Q) Carbon Oxide Sequestration Credit
Extends and expands the 45Q credit for carbon capture and sequestration for industrial or direct air capture facilities.

(45U) Zero Emission Nuclear Power Production Credit
Creates a new credit for electricity produced by a qualified nuclear power facility.

(45V) Clean Hydrogen Production Credit
Creates a new tax credit to incentivize clean hydrogen production.

(45W) Qualified Commercial Clean Vehicles Credit
Creates a new section 45W – Section 38(b) (37) the qualified commercial clean vehicle credit. The largest credit allowed is \$7,500 for vehicles weighing less than 14,000 lbs. For other vehicles the credit is \$40,000.

(45X) Advanced Manufacturing Production Credit
Creates a new credit to include production of other clean energy products and materials. (E.g., wind, solar, battery storage, inverters, applicable critical minerals components)

(45Y) Clean Electricity Production Credit
Expands tax credits for the production of clean energy.

(45Z) Clean Fuel Production Credit
Creates a new credit for clean fuel production

(48) Energy Credit
Extends and expands 48 Energy credit based upon the production of electricity from alternative clean energy resources.

(48C) Advanced Energy Project Credit
Extends the 48C Advanced Energy Project Credit to allocate credits for qualifying properties based on an application process.

(48E) Clean Electricity Investment Credit
New clean energy investment credit for qualified facilities and energy storage technology.

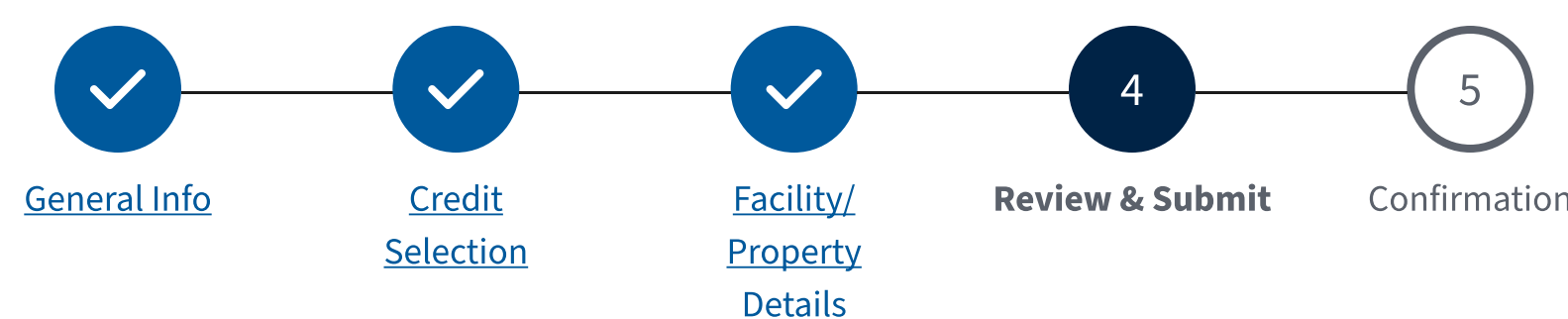

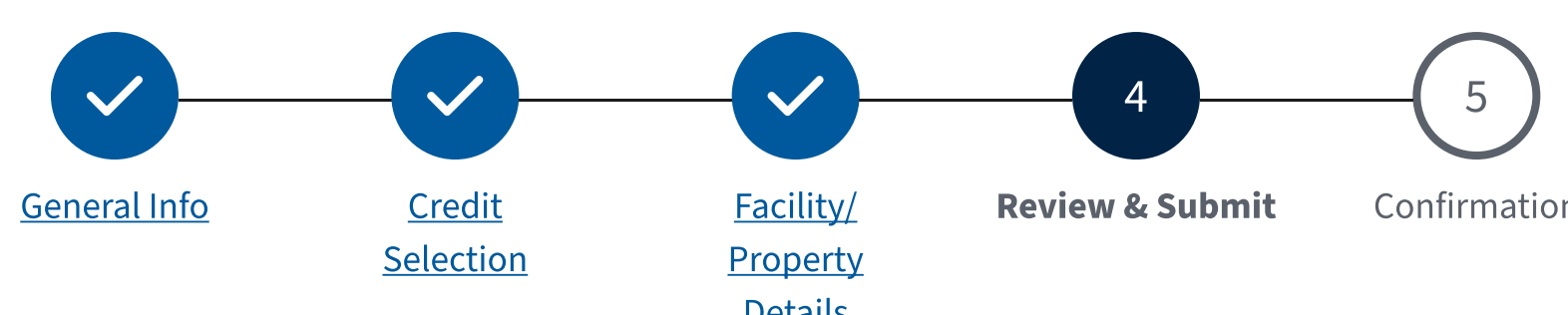
