The Manual Alternative Passenger Manifesting Tool (MAPM-I) is available at <https://www.my.af.mil/gcsc-af/USAF/AFP40/d/s6925EC1353610FB5E044090020E329A9/Files/a4t/s4t1/xman/hello.html>

MAPM-I is a stand alone tool that can be operated with minimal resources. It produces documents for the processing of passengers and pets on outbound missions, as well as, products that can be imported into GATES, e-Secure, and e-APIS systems in order to meet most requirements. MAPM-I can be used by passenger terminals that have lost the ability to access their regular automated passenger manifesting system and are using manual processing. Additionally, it can also be used by those serial ports that don't have a passenger manifesting system.
