### SUPPORTING STATEMENT FOR Certification of Identity

#### A. JUSTIFICATION

1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection. Attach a copy of the appropriate section of each statute and regulation mandating or authorizing the collection of information.

The collection is necessary to identify individuals requesting information under the Freedom of Information Act (FOIA). This certification is required under 5 U.S.C. Section 552a (2018).

2. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.

The information is used by the FOIA office that the request is forwarded to. The purpose of the form is to help identify first-party requesters when information on themselves is requested. The FOIA Office will file this form with the FOIA request in an individual file.

3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g., permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Use of an electronic signature is acceptable. This form may be filled out and filed electronically.

The form is used to ensure that a Certificate of Identity is on file. This information is not available elsewhere.

There is no significant impact on small business or other private entities.

Less frequent is not an option to protect personal information and to meet the requirements of 5 U.S.C. Section 552a (2018).

  - · requiring respondents to submit proprietary trade secret, or other confidential information unless the agency can demonstrate that it has instituted procedures to protect the information's confidentially to the extent permitted by law.

There are no special circumstances.

8. A Notice of Proposed Rulemaking was published in the Federal Register on January 6, 2023 (88 FR 1012). The comment period ended on May 7, 2023. The agency received one <u>comment</u>. The comment was more so related to the rule and not the information collection itself.

9. Explain any decision to provide any payments or gifts to respondents, other than remuneration of contractors or grantees.

No government funds will be used as payment or for gifts to respondents.

The certifications are maintained by the FOIA offices that provide the individual with the requested information pursuant to 5 U.S.C. Section 552. While no particular statements offering assurances of confidentiality are provided to the individual on the certification form, the FOIA office does comply with PII procedures.
