We are delighted to announce the launch of the MyTravelGov online portal! The portal will allow eligible U.S. citizens and nationals to create a secure account and access consular services 24 hours a day, 7 days a week. You will have a more direct way to communicate with us after creating and logging in to your account. MyTravelGov is a key part of our efforts to improve and modernize our consular services.

The first service we will launch in MyTravelGov will allow you to apply online for a Consular Report of Birth Abroad (CRBA). A CRBA documents the U.S. citizenship of children born overseas who acquire citizenship at birth through a U.S. citizen parent or parents.

After we launch the online application for a CRBA, future versions of MyTravelGov will support a range of Consular Services, allowing you to:

- Renew your U.S. passport,
- Petition on behalf of relatives for an immigrant visa

Part of a large systems modernization initiative, MyTravelGov will greatly improve efficiency and security of consular services worldwide. This is the only official site offering these services.

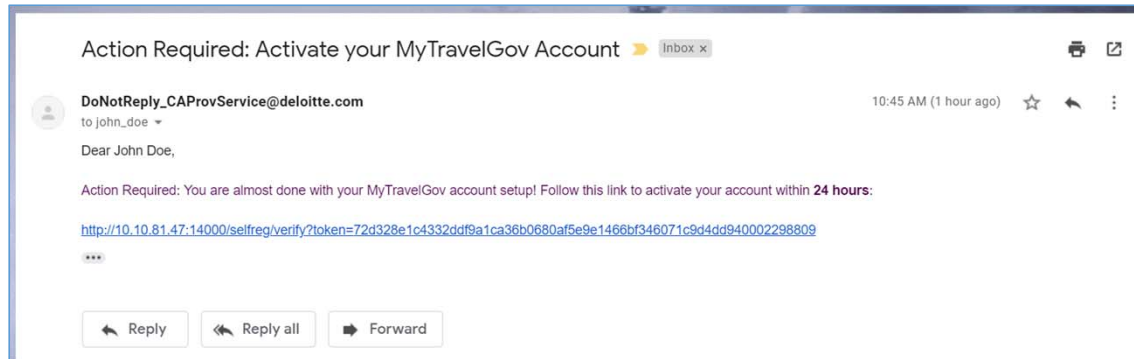
