Johnson Space Center (JSC) Flight Medicine Clinic (FMC) Information Collection electronic forms are presented as screenshots in this document.

Summary below, regarding the screenshots listed here that are used to collect information in the Electronic Medical Records (EMR) software used at the JSC, FMC:

1. Privacy Act popup all EMR users see when they access the EMR.

1. **Privacy Act screen view.**

This screenshot is of the privacy notice displayed to all authorized clinic staff logging into JSC, FMC EMR to collect information from public, former astronauts and/ or former payload specialists.

Privacy Act Notification
