A. JUSTIFICATION:

1. Explain the circumstances that make the collection of information necessary. Identify legal or administrative requirements that necessitate the collection of information.

The Department of Veterans Affairs (VA) through its Veterans Benefits Administration (VBA) administers an integrated program of benefits and services, established by law, for Veterans, service personnel, and their dependents and/or beneficiaries. Title 38 U.S.C. 5101(a) provides that a specific claim in the form provided by the Secretary must be filed for benefits to be paid to any individual under the laws administered by the Secretary. Additionally, 38 U.S.C. 501(a) provides VA the authority to collect this information. VA Form (VAF) 28-10286, Request For Retroactive Induction for a Period Previously Completed Under Chapter 33, collects information that the Veteran Readiness and Employment (VR&E) program needs to verify if a Service member or Veteran meets the criteria for retroactive induction for a period previously completed under Chapter 33 (38 U.S.C. 3102, 3103, 3108, 5113).

VA Form (VAF) 28-10286, Request For Retroactive Induction for a Period Previously Completed Under Chapter 33 (Chapter 31-Veteran Readiness and Employment) is a new form. VAF 28-10286 was developed to determine if a Service member or Veteran meets the criteria for retroactive induction for a period previously completed under Chapter 33 benefits, to include:

- Opt-in language for use of the claimant's email.
- New standardization data points; to include optical character recognition boxes.
- Electronic signature capabilities.
- The respondent burden has been determined to be 20 minutes.

A Service member or Veteran will use VAF 28-10286 to request a retroactive induction for a period previously completed under Chapter 33 benefits. The VR&E program subsequently uses the information on this form to determine if a Service member or Veteran qualifies for a retroactive induction under 38 U.S.C. 3102, 3103, 3108, 5113.

VA Form 28-10286 is available on the One-VA Website in a fillable electronic format. VBA is currently hosting this form on a secure server and does not currently have the technology in place to allow for the complete submission of the form. Validation edits are performed to assure data integrity. There currently is no utility process in place that will allow the data submitted on the form to be incorporated with an existing centralized legacy database.

- 4. Describe efforts to identify duplication. Show specifically why any similar information already available cannot be used or modified for use for the purposes described in Item 2 above.**

Program reviews were conducted to identify potential areas of duplication; however, none were found to exist. There is no known Department or Agency which maintains the necessary information, nor is it available from other sources within our department.

The collection of information does not involve small businesses or entities.

A Service member or Veteran will use VAF 28-10286 to request a retroactive induction for a period previously completed under Chapter 33 benefits. The VR&E program subsequently uses the information on this form to determine if a Service member or Veteran qualifies for restoration of entitlement. Without the information gathered on this form, the VR&E program would be unable to verify that the Service member or Veteran meets the criteria for retroactive induction.

The commenter wanted to know what was meant by “retroactive induction”. VR&E provided the definition of retroactive induction as specified in 38 C.F.R. 21.282.

A 30-Day Federal Register Notice (FRN) for the collection published on September 8, 2023. The 30-Day FRN Citation is Vol. 88, No. 173, page 62148. No comments were received during the 30-Day Comment Period.

No payments or gifts to respondents have been made under this collection of information.

10. Describe any assurance of privacy to the extent permitted by law provided to respondents and the basis for the assurance in statute, regulation, or agency policy.

The records are maintained in the appropriate Privacy Act System of Records identified as “Compensation, Pension, Education, and Veteran Readiness and Employment Records-VA (58VA21/22/28),” published at 74 FR 29275 on June 19, 2009, and last amended at 87 FR 8740 (February 16, 2022).

11. - b. Frequency of Response is on occasion.
- c. Annual burden hours are 33,000 hours.
- d. The estimated completion time for each form is 20 minutes.
- e. The respondent population for VA Form 28-10286 is composed of VR&E Service member or Veteran who requested a retroactive induction for benefits previously completed under Chapter 33. VA cannot make further assumptions about the population of respondents because of the variability of factors such as the educational background and wage potential of respondents. Therefore, VBA used general wage data to estimate the respondents' costs associated with completing the information collection.

The Bureau of Labor Statistics (BLS) gathers information on full-time wage and salary workers. According to the latest available BLS data, the mean hourly wage is \$28.01 based on the BLS wage code – “00-0000 All Occupations.” This information was taken from the following website: https://www.bls.gov/oes/current/oes_nat.htm.

Legally, respondents may not pay a person or business for assistance in completing the information collection. Therefore, there are no expected overhead costs for completing the information collection. VBA estimates the total cost to all respondents to be \$2,772,990.00 (99,000 burden hours x \$28.01 per hour).

This submission does not involve any recordkeeping costs.
