**TITLE OF INFORMATION COLLECTION:** NINDS Funding Webpage Feedback

**PURPOSE:**

To conduct usability testing for part of the NINDS website that includes information on NINDS research funding. Website users will be invited to share their experience using these webpages, and the data collected will be used to inform improvements to current funding pages in an effort to enhance readability and helpfulness for users. The usability testing will consist of a short introductory survey (online) followed by three interview questions asked as the participants visit and interact with the NINDS website.

**DESCRIPTION OF RESPONDENTS:**

The targeted group includes researchers who have and have not previously visited the NINDS website, ninds.nih.gov. Researchers in attendance at scientific conferences and other events will be invited to participate in this voluntary usability testing.
