TITLE OF INFORMATION COLLECTION: NLM Site-wide Survey for Website Satisfaction (2023)

PURPOSE:

The National Library of Medicine (NLM) wishes to collect feedback on user satisfaction with specific pages on the NLM websites such as www.nlm.nih.gov, pubmed.gov, MedlinePlus.gov, PubMed.gov, and others. NLM provides biomedical, historical, and consumer health information through its websites. Qualitative customer feedback obtained from this survey will help the Library to enhance and improve the design and operation of these publicly accessed websites.
