# Column 1 EMPLOYEE COUNT- ALL EMPLOYEES

Total number of persons in this pay group who worked or received pay for any part of the pay period that includes the 12<sup>th</sup> of the month.

### Include:

- Executives and their staff
- Full-time and part-time employees
- Salaried officials of corporations
- Trainees
- Employees on active duty, if
- Employees on paid sick leave
- Employees on other paid leave

### Exclude:

- Outside contractors and their employees
- Pensioners
- Proprietors, owners, or partners of unincorporated firms
- Employees on active duty, if not receiving pay from employer
- receiving pay from employer Employees on leave without pay for entire pay period
- Employees on paid vacation Employees on strike for entire pay period
  - Unpaid family members

### **EMPLOYEE COUNT- PRODUCTION EMPLOYEES**
