Due to a restriction on the number of sign-ons, we highly recommend that agencies share a single login/computer, when possible, to allow for more registrants. <u>If sharing a single login, only one person</u> <u>from a group will need to register</u> and serve as the primary registrant. There is no FBI limit to the number of participants who may view the training from a shared login. For example, multiple participants may view the training in a conference room on a shared screen and would only need to register one person. Participants who attend all three days of NIBRS training will receive a certificate of completion.

Agencies will be limited to a maximum of two logins.

After submission, the UCR Trainers will send a calendar invitation with more information about the training and how to attend the selected session(s).
