

# RNG Producer – Supplemental RNG Production Report (Report Form ID: RFS4800): Instructions for Completing

### Who must report

• RNG producers that produced RNG during the calendar quarter.

## **Reporting requirements**

- <u>40 CFR 80.140(c)</u> sets forth the reporting requirements for this form.
- Complete this report as a separate entry for each RNG production facility during the compliance period.
- If a report field does not apply, enter the value "NA". **Do NOT leave any field blank**.

## **Reporting Deadlines**

• RNG Producers must report on a quarterly basis as follows:

| Calendar Quarter | Time Period Covered     | Quarterly Report<br>Deadline |
|------------------|-------------------------|------------------------------|
| Quarter 1        | January 1 – March 31    | June 1                       |
| Quarter 2        | April 1 – June 30       | September 1                  |
| Quarter 3        | July 1 – September 30   | December 1                   |
| Quarter 4        | October 1 – December 31 | March 31                     |
