

## RFS2 Renewable Electricity RIN Generator – RIN Generation Fleet Outlook Report (Report Form ID: RFS4700): Instructions for Completing

### Who must report

- Generally, a Renewable Electricity RIN Generator generating RINs from a biogas-derived renewable fuel must comply with the reporting requirement found at 40 CFR § 80.150(d).

### Reporting Deadlines

- Renewable electricity RIN Generators must submit on a quarterly basis.

Quarter 1	January 1 – March 31	June 1
Quarter 2	April 1 – June 30	September 1
Quarter 3	July 1 – September 30	December 1
Quarter 4	October 1 – December 31	March 31
