

## RFS2 RNG Producer – RIN Generation Fleet Outlook Report (Report Form ID: RFS4800): Instructions for Completing

### Who must report

- Generally, a RNG producer generating RINs must comply with the reporting requirement found at 40 CFR § 80.150(e).

### Reporting Deadlines

- RNG Producers must submit on a quarterly basis.

Production Calendar Quarter	Time Period Covered	Quarterly Report Deadline
Quarter 1	January 1 – March 31	June 1
Quarter 2	April 1 – June 30	September 1
Quarter 3	July 1 – September 30	December 1
Quarter 4	October 1 – December 31	March 31
