

# RFS2 RNG RIN Retirement – Supplemental Report (Report Form ID: RFS5400): Instructions for Completing

## Who must report

• Generally, an entity retiring RNG RINs must comply with the reporting requirement found at 40 CFR § 80.150(h).

# **Reporting Deadlines**

Entities retiring RNG RINs must submit on a quarterly basis.
