### **Study Screener**

Welcome to Feeding My Baby and Me! This study is sponsored by the Centers for Disease Control and Prevention (CDC) to help understand the thoughts, experiences, and decisions on baby care and feeding from today's Moms like you.

- Complete two web surveys (25 30 minutes) about what **you** eat, one before the baby's born and one when your baby is 3 months old. You will receive \$50 for each.
