- 3. Among the categories of services just discussed (i.e., supportive, nutrition, and caregiver services) we are interested in learning how service utilization did or did not change as a result of the pandemic.
 - a. What supportive services were the most utilized before the pandemic? During the pandemic? After the pandemic?
 - b. What supportive services were the least utilized before, during, and after the pandemic?
 - c. What nutrition services were the most utilized before the pandemic? During the pandemic? After the pandemic?
 - d. What nutrition services were the least utilized before, during, and after the pandemic?
 - e. What caregiver services were the most utilized before the pandemic? During the pandemic? After the pandemic?

- 7. Which OAA funded partners, if any, helped the aging network implement programs and services during the pandemic, and how?

C. COVID Supplemental Funding

For the past several years, Title VI Programs have received supplemental funding (e.g., CARES, FFCRA, ARP, VAC5) and major disaster declaration flexibilities from the federal government in an attempt to continue or expand services during the pandemic.

D. Successes and Challenges

- 16. Are there any programs, services, innovations, or adaptations that you implemented during the pandemic or because of the pandemic that you have discontinued?
 - a. If yes, why did you stop offering them?

- 17. As you reflect back on the past several years and consider future emergency planning, what gaps in planning, relationships, or services still exist to successfully serve older adults? (What do Title VI Programs need to have in place in order to reach their goals of serving older adults)?
- 18. What kinds of services or activities did you wish you could do, but couldn't, even with the supplemental funding?

 - b. If a large influx of funding is available again, what would you do differently?
- 19. Are there policies or guidance that ACL could provide that would be helpful to Title VI Programs for future emergencies?
